PUBLIC HEARING

1. Consider request by Judy Peagler for a waiver of Code of Ordinance Section 5-95 metallic buildings to place a 12 x 20 metallic building in her back yard at 1900 Edwin Ave., Pearl, MS 39208.

The Public Hearing was opened with respect to whether or not a waiver of Code of Ordinance Section 5-95 metallic buildings to place a 12 x 20 metallic building in the back yard at 1900 Edwin Ave., Pearl, MS 39208. Judy Peagler, the owner, spoke in favor of the request. Community Development Director, Brad Robertson, informed the Mayor and Board of Aldermen that the requested building would fit with the other properties in this area and recommended granting the waiver.

Motion was made by Alderman Foy and seconded by Alderman Sartor to approve the request for a waiver of Code of Ordinance Section 5-95 metallic buildings to place a 12 x 20 metallic building in the back yard at 1900 Edwin Ave., Pearl, MS 39208. The following members of the Board of Aldermen voted in favor of the Motion,

which became the Orders of the Board: Alderman Foy, Alderman Gill, Alderman Steverson, Alderman Thompson, Alderman Luckett, Alderman McHenry and Alderman Sartor.

GENERAL BUSINESS

1. Consider Mayoral Veto with regard to request by Brandon Deer on behalf of Magnolia Equipment, LLC, for conditional use to operate a golf cart dealership at 315 Airport Rd., Pearl, Mississippi 39208.

Motion was made by Alderman Foy and seconded by Alderman Sartor to overturn the Mayoral Vetor with regard to the request for a conditional use variance at 315 Airport Road, Pearl, MS 39208 and no further discussion was made on the request. A voice vote was taken but no result was determined by the Mayor. The Mayor restated the Motion, asking for a roll call vote for alderman favoring the overturn of the Mayoral Veto granting of the conditional use as had been presented, same receiving no objection from the Movant or the Second. The roll call resulted in Alderman Sartor, Alderman Luckett, Alderman Thompson and Alderman Foy voting in favor to overturn the Mayoral Veto with regard to the request for a conditional use variance at 315 Airport Road, Pearl, MS 39208. Alderman Gill, Alderman McHenry and Alderman Steverson voted in opposition of Motion to overturn the Mayoral Veto with regard to the request for a conditional use variance at 315 Airport Road, Pearl, MS 39208. The Mayor announced that the Motion did not carry and the Veto stood therby denying the request to grant a conditional use to operate a golf cart dealership at 315 Airport Rd., Pearl, Mississippi 39208.

The Mayor informed the public that the current zoning ordinances were adopted in 2009 and that deviation from the zoning ordinances has the potential to hinder future development. Additionally, he read a letter from David Wade at Central Mississippi Planning and Development District wherein he advised against granting the request. (Said letter is attached hereto and incorporated herein by reference.)

Alderman Foy stated that for the record, it was his understanding that Mr. Wade admitted at the Work Session held on April 15, 2019, that his paragraph 1 of the letter sent was incorrect. Alderman Foy stated that paragraph read, "Vehicle repair and service businesses are not allowed outright (1301) or as a conditional use (1302) in the C-1 (Restricted Commercial District." Alderman Foy further stated that he had received numerous calls from constituents in support of this business and had 3 negative conversations regarding the same.

2. A Motion was made by Alderman Foy and seconded by Alderman Sartor to approve and authorize the purchase of 1500 sand bags with white sand ahead of the storms expected later in the week.

The following members of the Board of Aldermen voted in favor of the Motion, which became the Orders of the Board: Alderman Sartor, Alderman Steverson, Alderman Thompson, Alderman Luckett, Alderman Gill, Alderman Foy and Alderman McHenry.

There were no emergency consideration of committees, commission and board matters. Having no further business Mayor Windham asked that the meeting be adjourned.

Motion was made by Alderman McHenry and seconded by Alderman Sartor approving an order to adjourn the meeting. The following members of the Board of Alderman voted in favor of the Motion: Alderman Foy, Alderman Steverson, Alderman Sartor, Alderman Thompson, Alderman Luckett, Alderman Gill and Alderman McHenry.

Dear Mayor Windham:

I have reviewed your current (2009) Zoning Ordinance and based on my understanding of the requested conditional use. I have made the following findings:

- 1. Vehicle repair and service businesses are not allowed outright (1301) or as a conditional use (1302) in the C-1 (Restricted Commercial District).
- 2. Outdoor storage is expressly prohibited in the C-1 district under Sections 1300 and 1301.
- 3. Section 1303 expressly prohibits "Any use involving the outdoor storage of materials, inventory or equipment..." as well as "Warehouses and Storage Facilities".
- 4. The requirements for granting a Conditional Use under Section 2505 expressly address "General compatibility with adjacent properties and other property in the district."

Based on these findings, as well as my understanding that the request is for a utility vehicle (golf cart) service and repair shop to include outdoor display and storage along with warehousing, I recommend denial of the request. Another consideration is that we are just now beginning an update of the City's Comprehensive Plan. During the development of the Plan we will be considering and addressing land use development patterns as they relate to future zoning of lands. The allowance of otherwise incompatible land uses in an area could greatly affect the outcome of the new Land Use Plan.
