# GENERAL BUSINESS

Consider a Resolution requesting the Mississippi Legislature to authorize the City of Pearl to hold an election for the purpose of implementing a three (3%) percent tax of the gross proceeds of hotels and motels operating within the City of Pearl and a one (1%) percent tax of the gross proceeds of the restaurants operating within the City of Pearl, for the purpose of enhancing the parks and recreations programs and for promoting tourism to include regionally promoting the City of Pearl and for related purposes.

Motion was made by Alderman McHenry and seconded by Alderman Gill to adopt a Resolution to requesting the Mississippi Legislature to authorize the City of Pearl to hold an election for the purpose of implementing a three (3%) percent tax of the gross proceeds of hotels and motels operating within the City of Pearl and a one (1%) percent tax of the gross proceeds of the restaurants operating within the City of Pearl, for the purpose of enhancing the parks and recreations programs and for promoting tourism to include regionally promoting the City of Pearl and for related purposes. 2. Consider a Resolution requesting the Mississippi Legislature to authorize the City of Pearl to impose a special sales tax of not more than one (1%) percent for the purpose of improving infrastructure in the City, to include the overlay and resurfacing of city streets and for related purposes.

Motion was made by Alderman Thompson and seconded by Alderman McHenry to adopt a Resolution requesting the Mississippi Legislature to authorize the City of Pearl to impose a special sales tax of not more than one (1%) percent for the purpose of improving infrastructure in the City, to include the overlay and resurfacing of city streets and for related purposes. The following members of the Board of Aldermen voted in favor of the Motion which became the Order of the Board: Alderman Thompson, Alderman Foy, Alderman Sartor, Alderman Steverson, Alderman Gill, Alderman McHenry and Alderman Luckett.

3. Appoint Pearl Public School District board member.

Motion was made by Alderman Sartor and seconded by Alderman Foy to appoint Melissa Wade to the Pearl Public School District Board. The following members of the Board of Aldermen voted in favor of the Motion which became the Order of the Board: AldermanThompson, Alderman Foy, Alderman Steverson and Alderman Sartor; Alderman Gill, Alderman McHenry and Alderman Luckett recused themselves from the vote.

There were no emergency consideration of committees, commission and board matters.

Having no further business Mayor Windham asked that the meeting be adjourned.

Motion was made by Alderman Sartor and seconded by Alderman Foy approving an order to adjourn the meeting. The following members of the Board of Aldermen voted in favor of the Motion: Alderman Foy, Alderman Steverson, Alderman Sartor, and Alderman Thompson.
