# MINUTES OF THE REGULAR MEETING OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF PEARL, MISSISSIPPI, HELD IN THE BOARD ROOM AT CITY HALL MAY 04, 2021, AT 6:00 O'CLOCK P.M.

### CALL TO ORDER

The regular meeting of the Mayor and Board of Aldermen was called to order by Mayor Windham at 6:00 p.m.

## **PUBLIC HEARING**

1. Consider request by Otis "Scooter" Myers for a dimensional variance to allow him to build a 2,400 sq. ft. metal shop on his property located at 321 Longwood Ct.

Otis "Scooter" Myers appeared in support of his request. There was no one to speak in opposition of this request. Motion was made by Alderman Thompson and seconded by Alderman Luckett to accept the Community Development Director's recommendation and grant the request by Otis "Scooter" Myers for a dimensional variance to allow him to build a 2,400 sq. ft. metal shop on his property located at 321 Longwood Ct. The following members of the Board of Alderman voted in favor of the Motion which became the Order of the Board: Alderman Steverson, Alderman Gill, Alderman Sartor, Alderman Luckett, Alderman McHenry, Alderman Foy and Alderman Thompson.

2. Consider request by Greg Thibodeaux for a conditional use to operate a mobile automotive center from the building located at 2610-2612 Highway 80 E.

Greg Thibodeaux appeared in support of his request. There was no one to speak in opposition of this request. Motion was made by Alderman Sartor and seconded by Alderman Luckett to accept the Community Development Director's recommendation and grant the request by Greg Thibodeaux for a conditional use to operate a mobile automotive center from the building located at 2610-2612 Highway 80 E., there shall be no outdoor storage and all repaired vehicles left outside shall be retrieved the same day or stored overnight inside the building. The following members of the Board of Alderman voted in favor of the Motion which became the Order of the Board: Alderman Steverson, Alderman Gill, Alderman Sartor, Alderman Luckett, Alderman McHenry, Alderman Foy and Alderman Thompson.

Alderman Sartor voted against the Motion.

There were no emergency consideration of committees, commission and board matters. Having no further business Mayor Windham asked that the meeting be adjourned in memory of James Beason, Pete Enriquez, Maxine Trest, and Rex Allen.

Motion was made by Alderman Thompson and seconded by Alderman Sartor approving an order to adjourn the meeting in memory of James Beason, Pete Enriquez, Maxine Trest, and Rex Allen; The following members of the Board of Alderman voted in favor of the Motion: Alderman Steverson, Alderman Thompson, Alderman Sartor, Alderman Foy, Alderman McHenry, Alderman Luckett and Alderman Gill.
